REVIEW AND APPROVAL OF ACREAGE FEE COMMITTEE DISCUSSION

Weber presented the acreage fee proposal that was discussed at the Acreage Fee Committee meeting on August 22, 2025. The intent of revising the acreage fee chart is to create a more equitable fee structure for nurseries. CDFA and the Board must consider Food and Agricultural Code Section 6723 while amending the fees.

FAC 242 UPDATE
