# DO NOT SUBMIT PAYMENT WITH THIS APPLICATION.

A separate billing will be sent upon completion of supervision of requested activity.

- **Agreement #:** This number will be assigned/entered by CDFA. The agreement number will be the three digit county number and the number of the California License to Sell Nursery Stock, for example: 001-A1234.
- **Name and Address Block:** Enter the nursery or firm name, complete mailing address, telephone and facsimile numbers, and the county in which the headquarters of the nursery/firm is located.
- Location / Certification Requested Block: Indicate the county where the fields or treatment site is located. Enter information on separate lines for each county. Circle the appropriate activity for which certification is being requested. Enter the total estimated acres or square feet of treatment or sampling in each county. In the last column, enter the estimated total number of locations in each county.
- **Soil Treatment:** Soil treatment includes approved chemical fumigation of field, greenhouse, or other locations, heating of soil by steam or aerated steam, or by other methods approved by CDFA. Planting sites treated by approved methods are not required to be sampled for nematodes. *All applications of pesticides must be made in compliance with the applicable laws and regulations*.
- **Nematode Sampling:** Sampling for nematodes may be required when an approved soil treatment was not followed for planting nursery stock. The standard for field grown nursery stock is sampling on a 40 foot x 40 foot grid interval throughout the planting. Samples may be composited on an acre or nursery stock variety basis. For container, flat, and frame grown nursery stock, a composite sample from each lot is to be obtained by collecting roots from one plant in every 100 square feet of bench or frame space. *See California Code of Regulations, Section 3055.5, or Nursery Inspection Procedures Manual, Item #6, for more details of certification requirements.*
- **Commodity Treatment:** Commodity treatment must take place when an approved soil treatment or nematode sampling was not followed. Additionally, commodity treatment of nursery stock may be required if plant-parasitic nematodes are detected due to sampling. Commodity treatments are approved for specific nursery stock only. Check with CDFA or County Biologists for more information on nursery stock approved for commodity treatment.
- **Signature Block:** Sign your name in the appropriate box, indicate your designation/title (e.g., Owner, Manager, etc), and enter the current date.
