# **Seed Laboratory Report of Activities** FY 20-21 July 1, 2020 - April 15, 2021

# I. Label Compliance Testing

As of April 15, 2021:

- 244 regulatory samples released to the Seed Lab.
- 41% of the 600-sample target for FY 20-21.
- Vegetable seeds: 42% of total.
- Agricultural seeds: 32% of total.
- Lawn seeds: 26% of total.

## **II. Label Violations**

- 22 different types of violations, grouped into three categories:
  - Purity
  - Germination
  - Non-compliance with labelling standards/other violations

## **II. Label Violations**

- 14% of inspected lots had at least one type of violation.
- Lawn seed lots had the highest number/proportion of violations: 12/33 (19%).
- Agricultural seed lots: 12/78 (15%).
- Vegetable seed lots: 18/200 (12%).

# **III. Service Samples**

- 316 service (fee-based) samples tested in FY20-21-20; almost the same as in the same period of the previous FY (336).
- Rice was the most frequently tested crop (148 samples).
- Vegetables, especially tomatoes, lettuce, broccoli and cauliflower, made up the bulk of the remainder.
- 29 samples were submitted for seed identification.

### IV. Seed Regulatory Compliance Activities

- Approximately 63% of the time spent on regulatory activities was devoted to label compliance testing.
- 12% for providing consultations, information on seed testing rules and regulations, and investigative services.

### IV. Seed Regulatory Compliance Activities

- 8% on validation of existing Rules governing regulatory testing.
- 6% on monitoring and inspection activities within the regulatory framework.
- 11% on training staff and other analysts.
