APIARY REGISTRATION FEE SCHEDULE

Mr. Brad Pankratz, Apiary Task Force Chair, gave an update on the apiary fees. The task force brought forth a two-tier system for the yearly registration fee:
1-50 hives - \$100 registration fee
51 and more hives - \$250 registration fee

County Board of Supervisors will continue have the option to waive fees for hobbyist beekeepers with 9 or fewer hives per Food and Agricultural Code §29044.

Mr. Rick Gurrola, on behalf of CACASA, thanked the task force for the fee recommendations.

Mr. Trevor Tauzer moved that the Board establish an annual registration fee of \$100 for 1-50 hives, and \$250 for 51 or greater to be established January 1, 2024. The motion was seconded by Mr. Brent Ashurst.
